Teaches seminar on lawyering for systemic change, racial justice and community lawyering. Developed and teaches seminar on policing in Chicago. Developed and teaches seminar at Stateville Prison on mass imprisonment and violence reduction strategies.

Provided strategic guidance and legal support to justice reform campaigns in other Deep South states. Engaged in class action litigation and legislative advocacy. Supported community-based reform campaigns through technical assistance and legal representation. Supervised a team of fourteen lawyers and advocates. Selected accomplishments include a successful legal and advocacy campaign that lead a corrections agency to cancel its contract with the second largest private prison company in the world; a significant reduction in an adult jail population, legislation that reduced the number of children tried and convicted as adults; the closure of a notorious juvenile detention center, and the development of alternatives to imprisonment.
