PROJECTS AND STUDIES

Project on Qualification Guidelines for Judicial Candidates, 1981-83

This project was funded in part by a grant from the Pew Memorial Trust. The purpose of the project was to survey the literature on judicial selection and evaluation and identify qualities believed to be essential in good judges. The project then sought to define the qualities and suggest ways to measure or test for them, so that they could be used by individuals and groups who select and evaluate judges. Primary responsibilities on the project included researching the literature and relevant constitutional and statutory provisions, working with a special committee and drafting the project report.

Judicial Discipline and Disability Digest, 1977-1982

This project was intended to produce a research tool for judges, lawyers and judicial conduct commissioners on the case law of judicial conduct and ethics. Primary responsibilities on the project included collecting all the case law on the subject, creating a format and structure for a case digest, supervising over 20 law students who assisted on the project at various times over the five years, and coordinating design, typesetting and proofreading. Responsibilities for the project ended with the publication of the 1979 supplement in 1982.

National Endowment for the Humanities Planning Grant, 1979

This project was funded by a 6-month grant from the National Endowment for the Humanities. The purpose of the grant was to enable the Department of Educational Programs to develop new ideas for educational activities by meeting with seven distinguished academic humanists and drawing upon their collective expertise. Primary responsibilities on the project included communicating with the seven person advisory committee, coordinating meetings, and researching and writing the final project report.

Research Attorney, Court Unification Project, 1977-78

This 12-month study was national in scope and funded by LEAA. Eleven states were selected for intensive investigation. Primary responsibilities on the project included drafting a chapter detailing the history of court unification in each of the eleven states selected for in-depth investigation and drafting two chapters analyzing the problems encountered and solutions devised in implementing court unification.
