He was appointed by NARUC to

the Advisory Counsel of the Electric Power Research Institute and completed his term in August 2017. Commissioner Anderson served as an *ex officio* member of the Texas Reliability Entity's Board of Directors from May 2012 until January 2015.

An attorney with more than 30 years' experience in private practice (corporate and securities law and other regulatory and administrative legal matters) and public service, he previously served as Deputy Director and Director of Governmental Appointments for Texas Governors Bill Clements and Rick Perry, respectively. He served as a member of the Texas State Securities Board for more than seven years having been appointed by then Governor George Bush.

Commissioner Anderson received a bachelor's degree in international affairs from the School of Foreign Service at Georgetown University and a law degree from Southern Methodist University.



WARNER BAXTER is chairman, president and chief executive officer of St. Louis-based Ameren Corporation, parent company of rate-regulated energy companies that serve more than 2.4 million electric and 900,000 natural gas customers in Illinois and Missouri. The company, which also develops regional electric transmission projects, had 2015 revenues in excess of \$6 billion.

During his more than 20-year tenure at Ameren, Baxter has also served in a variety of leadership roles, including chief financial officer and president of Ameren Missouri.

Before joining Ameren in 1995, Baxter served as senior manager in PricewaterhouseCooper's LLP national office in New York City, serving as one of the firm's liaisons with the major accounting standard setting bodies in the United States. From 1983 to 1993, Baxter worked in the firm's St. Louis office, where he provided auditing and consulting services to clients in a variety of industries, including the energy industry.

member of the University of Missouri-St. Louis Chancellors Council and serves on the University of Missouri 100 Board.

Today, Baxter sits on several industry boards including the Edison Electric Institute; he is chair of the Electric Power Research Institute and serves on the management committee of The Edison Foundation's Institute for Electric Innovation. He is board chair of the St. Louis Regional Chamber and sits on the executive committee of Civic Progress St. Louis. Baxter also serves on the board of U.S. Bancorp. Additional boards he serves include Barnes Jewish Hospital and The Muny.

He also is actively involved with several charitable organizations, including serving as a member of the board of directors at Variety the Children's Charity of St. Louis, council member of the American Cancer Society's Coaches vs. Cancer National Board and as chair of the St. Louis Chapter of CEOs Against Cancer of Missouri.

A native of St. Louis, Warner and his wife, Cindy, have four children.

JOHN R. BEAR joined MISO in 2004 and has more than 25 years of executive leadership in the utility industry. As President and Chief Executive Officer of MISO since January 2009, he leads MISO's continuous efforts to work collaboratively and transparently with its members to reliably deliver low-cost energy through efficient, innovative, operations and planning.

Prior to his current position, Bear was MISO's President and Chief Operating Officer, overseeing the initial design, implementation and daily operation of MISO's energy markets and transmission system planning.

Previously, Bear was President of Houston-based Reliant Resources where he directed all operations and commercial activity for 14,000 megawatts of generation as well as serving as Managing Director of Reliant's European Operations.

He is currently an Advisory Board Member of the Energy Systems Network (ESN), an initiative focused on bringing "clean technology" solutions to market.

Bear is also a member of the Governance Board of the Ohio, Kentucky and Indiana Chapter of the Make-A-Wish Foundation and served as vice-chair of the Indiana Regional Board in 2009 and 2010.

Previously, Bear served as the 2010 President of the GO15, the world's largest power grid operators and was the 2011 Vice President. The GO15 shares knowledge on key issues representing more than 75 percent of the world's electricity demand and 3.4 billion customers on 6 continents.

He is a former Board member of NERC regional entity ReliabilityFirst, and a founding board member of the Amsterdam Power Exchange (APX).

Additionally, he holds a private sector job as a network engineer and previously served as the co-chair of the Council of State Government's Energy and Environment Public Policy Committee."



EDWARD GARVEY founded AESL Consulting in 2008 to provide strategic regulatory and public policy support to public utilities, thought leaders, and energy and telecommunications providers that offer incredible service, essential products and visionary ideas.

Prior to AESL Consulting, Edward was point person for former Minnesota Governor Tim Pawlenty on energy issues, climate policy and telecommunications as Deputy Commissioner of the Dept. of

Commerce (1/03 to 7/08). In this role Edward helped create nation-leading renewable

energy policies, implement one of the nation's most effective energy efficiency programs, craft Minnesota's response to climate change and encouraging significant transmission, pipeline and other energy infrastructure.

In announcing Edward's resignation on July 15, 2008, then-Governor Pawlenty said, "Edward has been an exceptional leader on energy issues for a number of years. We particularly appreciate his service as the first director of our new Office of Energy Security. His leadership has been one of the reasons Minnesota is a national leader in energy reform."

He also helped draft the November 2007 Midwestern Governors Association climate accord and energy platform.

The Office of Energy Security, that Edward Garvey led, consisted of 80+ technical and professional staff that advocated before the MN Public Utility Commission, analyzed rate cases, power purchase agreements, requests for new electricity generating facilities, transmission lines and pipelines, the state's energy information office, Minnesota's low-income energy assistance program and state telecommunications regulatory and policy development.

Prior to these roles, Edward was on the Minnesota Public Utilities Commission (2/97 to 10/02) and served as its chairman for three of those years. Before that he was the Director of the Minnesota Office of Environmental Assistance (1/95 to 1/97).

Edward obtained a BA from the U. of MN in 1983 and a JD from the U. of MN Law School in 1986. He received his MBA from the U. of St. Thomas in 1998.

Edward served as legislative assistant for energy and the environment for former US Senator Dave Durenberger in Washington DC (5/87-11/90). DANIEL YVES HALL was appointed to the Missouri Public Service Commission on September 27, 2013 by Governor Jay Nixon, and unanimously confirmed by the Missouri State Senate in January, 2014. He was appointed Chairman by Governor Nixon on August 10, 2015. He is the 101st PSC Commissioner in the 100-year history of the PSC – Missouri's oldest state agency. He is an active member of the National Association of Regulatory Utility Commissioners, serving as Vice Chair of the NARUC Committee on Water, the Washington Action Committee, and the Subcommittee on Education and Research. In addition, he serves on the Organization of MISO States Board of Directors and

Executive Committee, is Chair of the Financial Research Institute's Advisory Board, and is a board member on the Public Council for the Water Research Foundation.

Chairman Hall served as the Legislative Director to Governor Nixon from January 2009 until his appointment to the Commission.



CHUCK HARDER presently serves as Deputy Attorney General for Public Protection for the Office of Arkansas Attorney General Leslie Rutledge. Public Protection consists of four divisions: Consumer Protection, which fights deceptive trade practices, mediates disputes between consumers and businesses, and oversees charities registration; Consumer Utilities Rate Advocacy, which is the voice of consumers as it relates to public utilities; Environmental, which represents the Arkansas Department of

Environmental Quality and the Pollution, Control & Ecology Commission and challenges rules that adversely affect the State; and Tobacco, which administers the Tobacco Master Settlement Agreement.

Mr. Harder has 28 years of experience in the energy industry. He previously served as Assistant Attorney General representing the interests of utility ratepayers in matters before the Arkansas Public Service Commission, the Arkansas General Assembly and Federal agencies. MIKE HUEBSCH was appointed to a six-year term at the Public Service Commission of Wisconsin by Governor Scott Walker on March 1, 2015, and confirmed by the state Senate in April 2015.

Commissioner Huebsch began state service in 1995 representing western Wisconsin's 94th Assembly District for sixteen years as a Republican in the state Legislature. He served two terms on the budget-writing Joint Finance Committee, including one as vice-chair. In the following years, he was elected by his colleagues to serve first as Assembly Majority Leader and then as Assembly

Speaker. As Speaker, he led the negotiations on Wisconsin's \$60 billion budget and set the policy agenda for the state Assembly. He was also responsible for managing the budget and personnel policies of the 99 member body and more than 200 staff.



Her recent scholarly work, published in many of the nation's leading law journals, addresses regulatory challenges to integrating more renewable energy into the nation's electric transmission grid, siting and eminent domain issues surrounding interstate electric transmission

lines and oil and gas pipelines, and applications of the public trust doctrine to modern environmental law challenges. She is a co-author of *Energy Law and Policy* (West Academic Publishing 2015) (with Davies, Osofsky, Tomain, and Wilson), *The Practice and Policy of Environmental Law* (Foundation Press, 4th ed. 2017) (with Ruhl, Salzman, and Nagle) and *Energy Law: Concepts and Insights* (Foundation Press 2017) (with Hannah Wiseman). Prior to her teaching career, Professor Klass was a partner at Dorsey & Whitney LLP in Minneapolis, where she specialized in environmental law and land use litigation. She received her B.A. from the University of Michigan and her J.D. from the University of Wisconsin Law School. She was a law clerk to the Honorable Barbara B. Crabb, U.S. District Court for the Western District of Wisconsin. She is a member scholar at the Center for Progressive Reform and a Fellow and Advisory Board member at the University of Minnesota's Institute on the Environment. She served as Associate Dean for Academic Affairs at the University of Minnesota Law School from 2010-2012. She was a Visiting Professor at Harvard Law School in 2015.



CLAIR J. MOELLER Executive Vice President of Transmission. As an executive leader of the office of the Chief Operating Officer, Mr. Moeller is responsible for MISO's transmission planning functions and transmission services. He is a well-respected industry expert with more than 25 years of experience in the operation of power systems in the Upper Midwest.

Mr. Moeller is skilled at identifying and implementing best practices in transmission planning and operations. His current focus is infrastructure planning in collaboration with the utilities that serve the 15 states and one Canadian province that comprise the MISO region. Under his guidance, transmission planners in the region

have begun to explore transmission infrastructure value by utilizing techniques borrowed from generation and strategic planners in an effort to give policymakers context for the decisions they will face as the electric energy future unfolds.

Elected to the Public Service Commission at age 30, he was the youngest Commissioner ever elected in Mississippi. Prior to his election to the Public Service Commission, he served as Mayor of Nettleton from 2001 to 2007, having been elected at the age of 23, making him one of the youngest mayors in Mississippi history.

Commissioner Presley currently serves as Chairman for the Mississippi Public Service Commission. He has also served as President of the Southeastern Association of Regulatory Utility Commissioners, which is composed of Public Service Commissioners from the eleven (11) Southern State and Puerto Rico. He currently serves as chairman of the Consumer Affairs Committee for the National Association of Regulatory Utility Commissioners (NARUC) and also serves on the Natural Gas and International Relations Committees. He is a former member of the board of directors of the National Regulatory Research Institute (NNRI). He currently serves on the advisory committee for the New Mexico's State University Center for Public Utilities.

Commissioner Presley, 39, is a lifelong resident of Nettleton, where he is a member of the Enon Primitive Baptist Church. He is past-President and current member of the Nettleton Lions Club and is a member of the Nettleton Civitan Club.



MATTHEW SCHUERGER was appointed to a six-year term on the Minnesota Public Utilities by Governor Mark Dayton on January 19, 2016.

Commissioner Schuerger has thirty-five years of experience in the energy industry as a senior manager and professional engineer including work with power system planning, energy markets, grid modernization, distributed energy resources, grid integration of renewable energy, strategic planning, and business development. From 2001 until he was named to the Commission, Schuerger was

the President of an engineering and management consulting firm. Prior to that, he was the Executive Vice President of District Energy St. Paul Inc., a privately held provider of district heating, district cooling, and cogenerated electricity.

Schuerger earned a Master's of Science in Electrical Engineering from the University of Minnesota, a Master's in Business Administration from the University of St. Thomas, and a Bachelor's of Science in Mechanical Engineering from Purdue University.

He serves on the Organization of MISO States Board of Directors and on the MISO Advisory Committee. In addition, he is a member of NARUC's Committee on Electricity and he serves on the Advisory Council of the Electric Power Research Institute.

His term expires in January 2022.



DAVID SHANKS is the Boeing representative to the Missouri Industrial Energy Consumers, a utility ratemaking interest group. He is also responsible for environmental regulatory surveillance and advocacy for Boeing manufacturing locations in Rocky Mountain, Midwest, and Eastern states. He has worked in environmental and energy policy for the past 32 years, for McDonnell Douglas, then for The Boeing Company when the companies merged.

After completing graduate work in natural resources at Colorado State University, David served in the Peace Corps in Dominica,

West Indies. He then served in environmental staff positions at EPA Region VIII and Offutt Air Force Base in Omaha. In mid-career, David completed a law degree at Saint Louis University, and later a LLM in Environmental Law at Vermont Law School.



BETH SOHOLT is the Executive Director of the non-profit organization Wind on the Wires (WOW). WOW is the Midwest's premier organization focused on driving the development of renewable energy by applying technical expertise, and by expanding markets and building support in the Midwest. Launched in 2001, WOW members include non-profit clean energy and environmental advocacy organizations, wind and solar developers, wind turbine manufacturers, and businesses that provide goods and services to the wind and solar industries. The WOW footprint covers 9 states that stretch from the Dakotas to Indiana. WOW is a key regional partner of the American Wind Energy Association.

Beth is responsible for guiding WOW's work in the areas of transmission planning, state regulatory proceedings, legislative policy, and education/outreach and serves on the board of directors. She holds a seat on the Midwest Independent System Operator (MISO) Advisory Committee representing the Environmental Sector.
